

## Patent Assignment



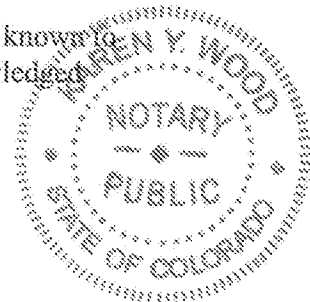


