PATENT AND DESIGN RIGHTS ASSIGNMENT

This Assignment, made this 14<sup>th</sup> day of June, 2013, is by and between NUADI S.A.R.L., a company organized under the laws of Luxembourg with a business address of 46A, Avenue J.F. Kennedy, L-1855, Luxembourg, registered with the Luxembourg Trade and Companies Register under number B117456 and having a share capital of EUR 10,012,500 (hereinafter the "Assignor"), and R.A. INVESTMENT MANAGEMENT S.A.R.L., a company organized under the laws of Luxembourg, with a business address of 46A, Avenue J.F. Kennedy, L-1855, Luxembourg, registered with the Luxembourg Trade and Companies Register under number B156769 and having a share capital of EUR 692,544 (hereinafter the "Assignee").

WHEREAS, Assignor is the owner of the patent and industrial design assets listed in Schedule A (the "Patent and Design Assets");

WHEREAS, Assignor and Assignee are parties to a Transfer and Set-off Agreement dated as of 14<sup>th</sup> day of June, 2013 ("Transfer and Set-off Agreement"), pursuant to which Assignor has agreed to sell, assign and transfer to the Assignee and Assignee has agreed to purchase from Assignor the Purchased Assets (as defined in the Transfer and Set-off Agreement), including without limitation the Patent and Design Assets; and

WHEREAS, Assignor wishes to transfer all of its worldwide rights in and to the Patent and Design Assets to Assignee and Assignee wishes to acquire all of the Assignor's worldwide rights in and to the Patent and Design Assets;

NOW THEREFORE, for and in exchange for the payment of the purchase price set forth in the Transfer and Set-off Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign to Assignee all right, title and interest in and to the Patent and Design Assets, and any and all patents, design patents and registered and unregistered designs that have been or may be granted or recognized for the inventions and designs disclosed therein, and all foreign or international filings, divisions, continuations, continuations-in-part of said applications, and reissues, renewals and extensions of said patents, design patents and registered and unregistered designs.

Assignor further agrees to sign all such additional documents as Assignee may require in order to confirm or to give full effect to this assignment, without additional consideration, including, without limiting the generality of the foregoing, any and all patent and industrial design applications and any and all forms in relation to such applications.
