Ownership of Asset. To the knowledge of the ASSIGNOR, all persons and entities who have developed the Inventions, including the inventors, filed the Application or otherwise assisted with the development of the Assets have assigned all of their rights and interests in the Assets to either American Shared Hospital Services or NBBJ, LP.
