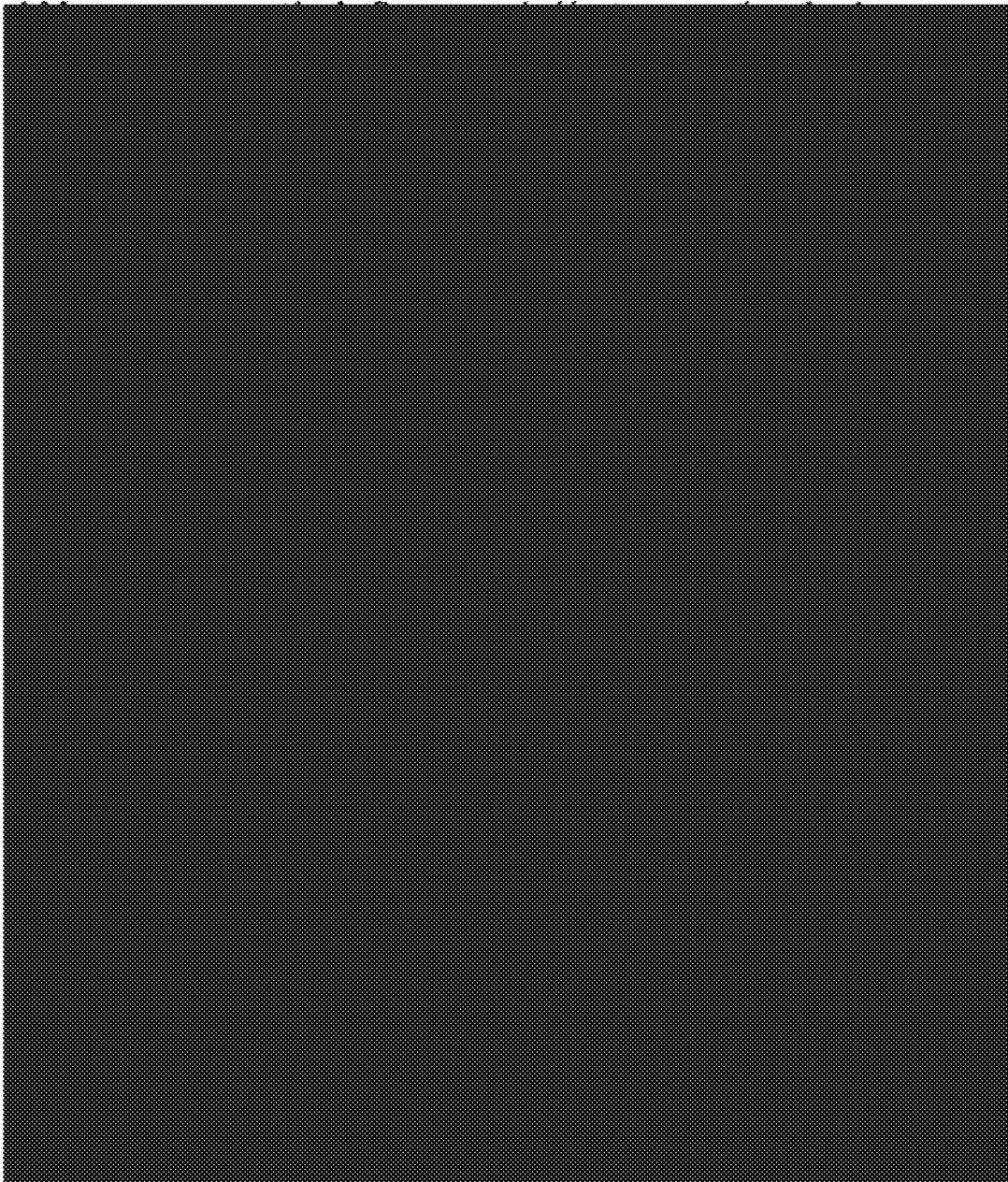


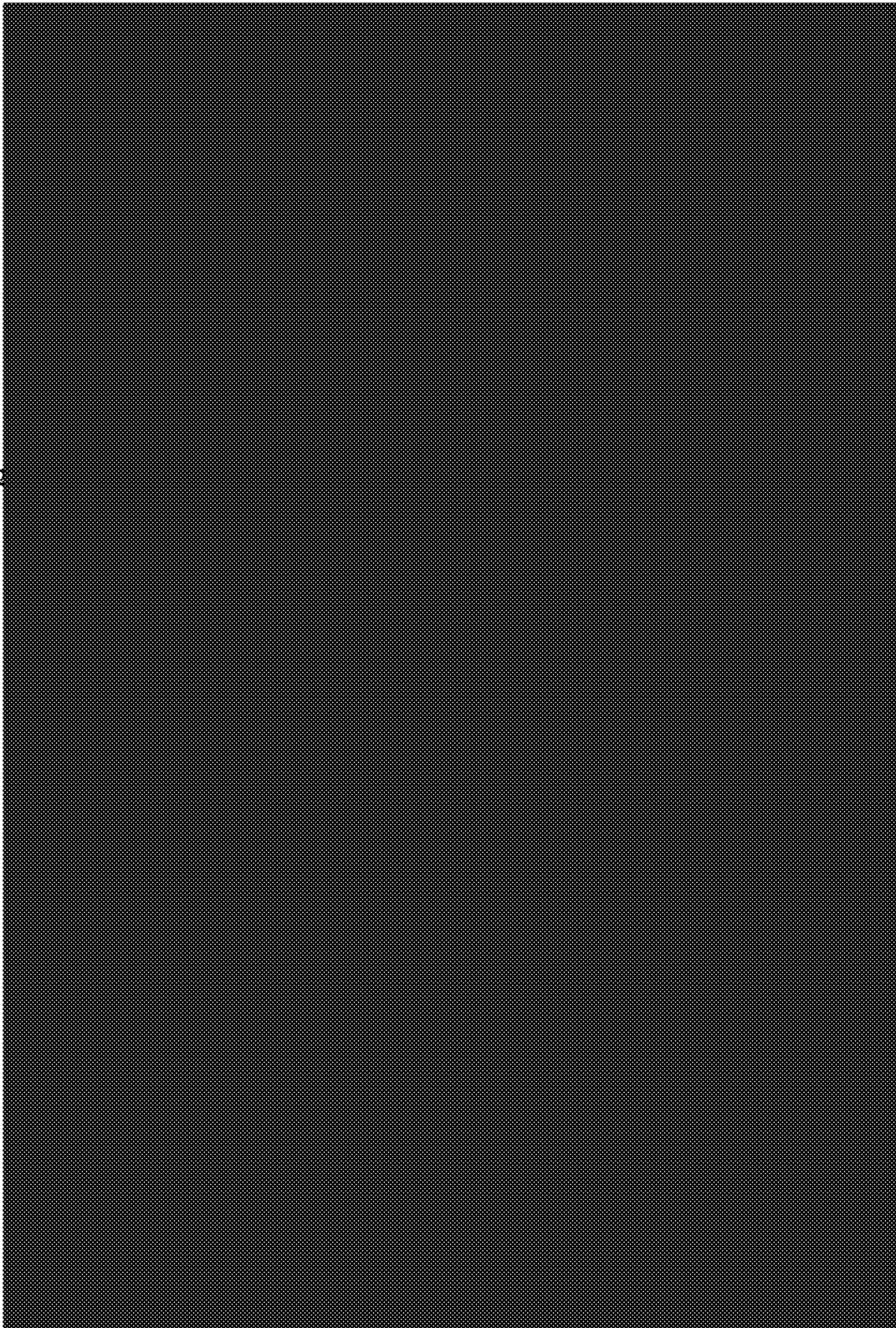
**INVENTION DISCLOSURE, CONFIDENTIALITY & PROPRIETARY RIGHTS
