AGREEMENT made this 30th day of November, 2012 between David Freedland with an address at 615 S. Atlantic Avenue, Beach Haven, New Jersey 08008 and Donna Freedland also with an address at 615 S. Atlantic Avenue, Beach Haven, New Jersey 08008.

David Freedland has developed, designed and created a curtain hanging system for Shower and other Curtains including, but not limited to Cubicle (Privacy) Curtains, Window Curtains and Dressing Room Curtains and had been granted US patent number 8,118,078 for the same. The technology to be patented is referred to in this Agreement as PreHooked. It is known by both parties that PreHooked is a tentative name and may or may not be changed. If the PreHooked name changes there will no change to this Agreement other than the change in the reference name.

David Freedland has also established PreHooked Products, LLC (a New Jersey, LLC) for purposes of holding the patent and developing products that would utilize the PreHooked technology.


David Freedland and Donna Freedland agree as follows:

1. David Freedland hereby grants and assigns 100% ownership interest in US Patent 8,118,078 to Donna Freedland for consideration of \$1.
2. David Freedland hereby grants and assigns 100% ownership of PreHooked Products, LLC (a New Jersey, LLC) to Donna Freedland for consideration of \$1.
3. Donna Freedland hereby assigns nominee ownership of the US Patent 8,118,078 and PreHooked Products, LLC. to David Freedland for the purpose of negotiating and granting license arrangements to third parties.
4. All proceeds from any licensing arrangement obtained are to be paid to Donna Freedland.

6. The nominee cannot make decisions about the property without the express authorization of the owner. The nominee can only perform, or execute, certain instruments including performing or delivering the following types of documents:
- (A) Licensing Agreements related to the property.
 - (B) Product purchase orders
 - (C) Purchase Agreements.
7. The nominee may collect revenues and receipts from the execution of business transactions related to the property on behalf of the owner. The nominee is required to remit to the owner all financial instruments and the proceeds from transactions conducted through normal business activities. The nominee incurs no liability and is not responsible for performing contracts between the owner and a third party.
