INTELLECTUAL PROPERTY SECURITY INTEREST RELEASE

This INTELLECTUAL PROPERTY SECURITY INTEREST RELEASE, dated as of April 22, 2016 (this "Release") by BRIDGE BANK, NATIONAL ASSOCIATION ("Lender") is made with reference to the *Business Financing Agreement*, dated as of May 20, 2015 (as amended from time to time, the "Financing Agreement"), between Lender and SOL REPUBLIC INC., a Delaware corporation, ("Grantor"), and to the *Intellectual Property Security Agreement* dated May 20, 2015 (the "Security Agreement") between Lender and Grantor. Terms defined in the Financing Agreement and terms defined in the Security Agreement have the same meaning when used in this Release.

Lender agrees that all actions and other obligations of Grantor necessary to obtain Lender's release of all of its rights in the Intellectual Property Collateral—whether set forth in the Financing Agreement or otherwise—have been discharged, and for other good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby covenants and agrees as follows.

Lender hereby terminates and releases all of its security interest, and otherwise waives all of its rights, in the Intellectual Property Collateral, including in all of the following, whether now existing or hereafter acquired or created in any and all of the following property:

(a) copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held (collectively, the "Copyrights"), including the Copyrights described in Exhibit A;

(b) trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Borrower connected with and symbolized by such trademarks (collectively, the "Trademarks"), including the Trademarks described in Exhibit B;

(c) patents, patent applications and like protections including without limitation improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same (collectively, the "Patents"), including the Patents described in Exhibit C;

(d) mask work or similar rights available for the protection of semiconductor chips or other products (collectively, the "Mask Works");

(e) trade secrets, and any and all intellectual property rights in computer software and computer software products;

(f) design rights;

(g) claims for damages by way of past, present and future infringement of any of the rights included above, and all rights to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

(h) licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works, and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(i) amendments, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and

(j) proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.


