ASSIGNMENT

THIS ASSIGNMENT is made the 12th day of APRIL 2016,

PARTIES

(together, the "Assignors"); and

- 3) AlloyGator Limited incorporated and registered in England and Wales with company number 06226009 whose registered office is at The Lodge Castle Bromwich Hall Chester Road, Castle Bromwich, Birmingham, B36 9DE, United Kingdom and whose trading address is 61 Heming Road, Washford Industrial Estate, Redditch, Worcestershire, B98 0EA, United Kingdom (the "Assignee").

BACKGROUND

- (A) The Assignors are the proprietors of the patents and patent applications listed in the Schedule (the "Applications"), in respect of the Inventions respectively disclosed in Applications (the "Inventions").

1. Pursuant to said Agreement and in consideration of the sum of £1.00 (One Pound Sterling) now paid by the Assignee to the Assignors (the receipt whereof is hereby acknowledged) the Assignors hereby assign, release and convey to the Assignee with full title guarantee the Applications, the Inventions, and the sole and exclusive benefit thereof, the right, title and interest therein, and all the rights, powers, privileges and immunities conferred on the owner thereof by the granting of the Applications and the Inventions free from all incumbrances and including the right to sue for damages and other remedies in respect of any infringement of the Applications, **TO HOLD** the same unto the Assignee absolutely.
2. The Assignors and the Assignee agree to execute any such further supplemental documentation as may reasonably be required by the Assignee in order to register the Assignee as proprietors of the Applications at the respective local Patent Offices around the world (hereinafter referred to as the "Local Documents").

3. Each of the Local Documents and this Agreement shall be regarded as one and the same instrument and in the event of any conflict between the terms of any of the Local Documents and this Agreement, the terms of this Agreement shall prevail.
4. This Agreement shall be governed by the laws of England and Wales and the parties agree to submit to the jurisdiction of the English courts.


