ASSIGNMENT OF INVENTION

WHEREAS, I, **HORST LOEHNERT**, of Ostfildern, Germany, have invented a certain new and useful improvement in a utility application for a **KNIFE HAVING AN RFID TRANSPONDER ARRANGED ON THE TANG**, to be filed in the U.S. Patent and Trademark Office and which claims priority to International Patent Application No. PCT/EP2014/069319 filed on September 10, 2014, which claims priority to German Patent Application No. 10 2013 219 875.2 filed on October 1, 2013.

DICK GMBH & CO. KG**, the entire right, title, and interest in said invention, said application, and in and to any and all Letters Patent of the United States, and countries foreign thereto, which may be granted for said invention, and in and to any and all priority rights, rights under the International Convention for the Protection of Industrial Property, rights under the Patent Cooperation Treaty, and other benefits accruing or to accrue to me with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto. This assignment assigns the right to claim priority to any previously filed provisional or utility application noted herein, as well as the right to be granted a patent in PCT Contracting States.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said **FRIEDR. DICK GMBH & CO. KG**, as the assignee of the whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
