

And **ASSIGNOR** further covenants and agrees, in consideration of the premises that **ASSIGNOR** will at any time upon request communicate to **ASSIGNEE**, its successors and assigns, any facts relating to the invention and discoveries and the history thereof, known to **ASSIGNOR** and that **ASSIGNOR** will testify as to the same in any interference, arbitration or other litigation when requested to do so by **ASSIGNEE**, its successors and assigns.
