## ASSIGNMENT

WHEREAS, the **University of Utah** (an institution of higher education and a nonprofit organization, organized and existing under the laws of the State of Utah, located at Salt Lake City, Utah) (hereinafter "Assignor") is the owner of an HYDROMETEOR IDENTIFICATION METHODS AND SYSTEMS for which a United States Patent Application was filed on February 25, 2016 as THORPE NORTH & WESTERN, LLP Docket No. 00846-U5901.NP, and given U.S. Patent Application Serial No. 15/053,951; and
