
ASSIGNMENT BY INVENTORS

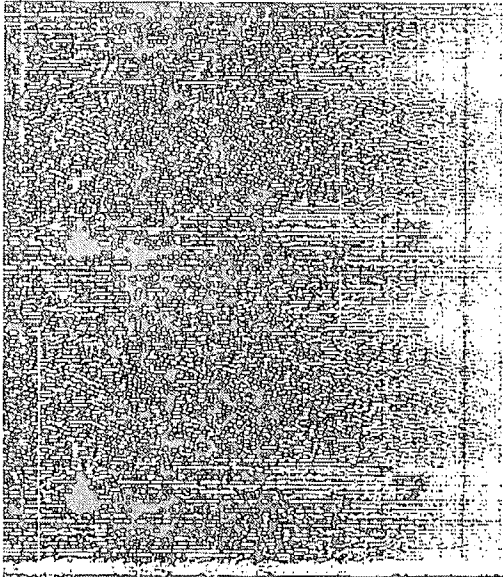
