**ASSIGNMENT AGREEMENT**

**AND I the Inventor** for myself and my executors and legal representatives hereby agree to provide information and make execute and deliver any and all other instruments in writing, and any and all further acts, applications, papers, affidavits, assignments and other documents which may be possible and are necessary or desirable to more effectually secure to and vest in **EMPLOYER** its successors and assigns, the whole right, title and interest in and to **the Invention** and any patent application or patent or Supplementary Protection Certificate relating thereto;
