DESIGN PATENT ASSIGNMENT

The Assignors hereby agree to do without further consideration all such things and execute all such documents as may be necessary or desirable to obtain and maintain design patents for the said design and for additions and modifications thereto

in any and all countries, and to vest title thereto in said Assignee, its successors, assigns and legal representatives or nominees.

The Assignors hereby authorize and request the Commissioner of Patents and Trademarks to issue said Design Letters Patent the said Assignee, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which Design Letters Patent may be granted as fully and entirely as the same would have been held by me had this assignment and sale not been made.

The Assignors hereby grant the firm of Bereskin & Parr LLP (40th Floor, 40 King Street West, Toronto, Ontario, Canada M5H 3Y2) the power to insert on this assignment any further identification and any translation which may be necessary or desirable in order to comply with the rules for recordation of this document in any country.


