FOURTH: The merger is to become effective at 11:59 p.m. on August 31, 2012.

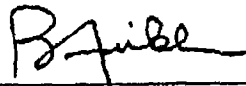
FIFTH: The Agreement and Plan of Merger is on file at 700 W. Park Avenue, Perkasio Pennsylvania 18944.
