INTELLECTUAL PROPERTY ASSIGNMENT
ASSIGNMENT

This AGREEMENT is between:

SpringSoft USA, Inc., a corporation in liquidation that was duly organized under the laws of California, having its principal place of business at 690 E. Middlefield Rd., Mountain View, CA 94043, U.S.A. (hereinafter "SPRINGSOFT USA"), and

Synopsys, Inc, a corporation organized and existing under the laws of the State of Delaware, U.S.A., having its principal place of business at 690 E. Middlefield Rd., Mountain View, CA 94043, U.S.A. (hereinafter "SYNOPSIS").

"Patent Properties" shall mean the U.S., international, and foreign patents and patent applications listed in the attached Schedule A.

"Additional Patent Properties" shall mean any additional U.S., international, and foreign patents and patent applications that arise from the Patent Properties. By way of example, but not limitation, Additional Patent Properties shall include:

1. any applications claiming priority, directly or indirectly, from any of the Patent Properties (including utility patents, design patents, utility models, and industrial designs);
2. any national or regional phase applications of any of the Patent Properties that are International (PCT) applications;
3. any national patents arising from the grant as a European patent of any of the Patent Properties that are European patent applications;
4. any letters patent or registrations which may hereafter be granted on any of the Patent Properties or on any patent application claiming priority directly or indirectly from any of the Patent Properties; and
5. any division, renewal, continuation in whole or in part, substitution, conversion, reissue, prolongation, or extension of any of the Patent Properties including letters patent or registrations arising from the Patent Properties.

WHEREAS, SPRINGSOFT USA (formerly known as Novas Software Inc., a California corporation) was the surviving corporation of a merger with Fortelink Inc., a California corporation.

WHEREAS, SPRINGSOFT USA has developed and owns, and holds right, title, and interest to the Patent Properties and any Additional Patent Properties.

WHEREAS, SYNOPSIS desires to acquire SPRINGSOFT USA's entire right, title, and interest in the Patent Properties, and any Additional Patent Properties.

WHEREAS, SPRINGSOFT USA adopted a plan of liquidation on October 21, 2015, whereby all remaining assets shall be distributed to the sole shareholder as a liquidating distribution.

THEREFORE, SPRINGSOFT USA does hereby assign to SYNOPSISYS and its successors and assigns, and SYNOPSISYS accepts all right, title and interest in and to the Patent Properties, and the Additional Patent Properties as a liquidating distribution.

The right, title and interest, is to be held and enjoyed by SYNOPSISYS and SYNOPSISYS'S successors and assigns as fully and exclusively as it would have been held and enjoyed by SPRINGSOFT USA had this Assignment not been made.

This Agreement shall be governed and construed under the laws of the State of California without regard for conflict of laws principles.

IN TESTIMONY WHEREOF, SPRINGSOFT USA and SYNOPSISYS have signed on the date indicated.


