ASSIGNMENT OF INVENTION

ASSIGNORS further covenant and agree to communicate to ASSIGNEE or its representatives any facts known to them respecting said application and invention, to testify in any legal proceedings related thereto, sign all lawful papers, to execute all divisional, continuation, substitute, renewal, extension, and reissue applications, to execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, and to make all rightful oaths, declarations or affidavits and generally do everything possible to aid said ASSIGNEE and its representatives to obtain and enforce proper protection for said invention in the United States of America and in any and all foreign jurisdictions; and

ASSIGNORS further covenant and agree that the terms, covenants and conditions of this Assignment shall inure to the benefit of ASSIGNEE, its successors, assigns, and legal representatives, and shall be binding on us, our heirs and legal representatives.
