## **AMENDED AND RESTATED ASSIGNMENT OF INVENTION**

THIS AMENDED AND RESTATED ASSIGNMENT OF INVENTION is made and entered into effect as of 24 March 2016, by and between **WAYNE EDWARD AUSTIN** and **HARDWARE AND GLASS GROUP LIMITED** and corrects and supersedes the Assignment of Invention recorded in the United States Patent Office on 3/29/2016 under Reel/Frame 038125/0342 which inadvertently listed the ASSIGNEE as Hardware And Glass Group Pty Limited, a corporation existing under the laws of Australia, whose address is 8 McIntosh Avenue, Padstow Heights 2211, NSW, Australia. The correct name and address of the ASSIGNEE is **HARDWARE AND GLASS GROUP LIMITED, a corporation existing under the laws of Hong Kong, located at Suite 801, 8th Floor, 20 Queens Road Central, Hong Kong.**

WHEREAS, **WAYNE EDWARD AUSTIN**, (a citizen of Australia) residing at 8 McIntosh Avenue, Padstow Heights 2211, NSW, Australia is a co-inventor and co-applicant of United States Patent Application No. 15/024,903 filed in the United States Patent Office on 25 March 2016 (hereinafter referred to as ASSIGNOR) of certain new and useful improvements in

(herein referred to as the INVENTION) which claims priority to PCT Application No. PCT/NZ2014/000209 filed 29 September 2014 which claims priority to New Zealand Patent Application No. 616060 filed 27 September 2013 for which he has made an application for a Letters Patent in the United States; and

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR has sold, assigned, transferred and set over and do hereby sell, assign, transfer and set over to the said ASSIGNEE, the said INVENTION and application, and any and all divisions and continuations thereof, and any and all Letters Patent of the United States, its territorial possessions, and any and all foreign countries which may be granted therefore, and any and all reissues and reexaminations of said Letters Patent, including the subject matter of any and all claims which may be obtained in every such patent, the same to be held and enjoyed by the said ASSIGNEE for its own use and behoof, and for the use and behoof of its successors, assigns, or other legal representatives, to the end of the term or terms for which said Letters Patent of the United States, territories and foreign countries are or may be granted, reissued, or reexamined as fully and entirely as same would have been held and enjoyed by ASSIGNOR, as if this assignment and sale had not been made.


AND, ASSIGNOR hereby authorizes and requests the Commissioner of Patents to issue any and all Letters Patent of the United States on said INVENTION, or resulting from said application, and from any and all divisions and continuations thereof to the said ASSIGNEE, of the entire interest, and hereby covenants that he has full right to convey the entire interest therein assigned, and that he has not executed and will not execute any agreement in conflict therewith.



AND, ASSIGNOR do further covenants and agrees, that he will, at any time, upon request, communicate to said ASSIGNEE, its successors, assigns, or other legal representatives, at its expense, such facts relating to said INVENTION and Letters Patent or the history thereof, as may be known to him, and testify as to the same in any interference or other litigation, when requested to do so.
