FURTHER, I agree to execute further instruments proper for effectuating the premises.



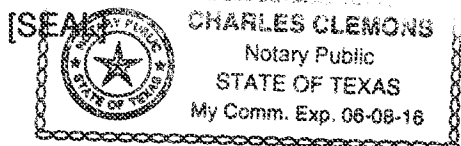

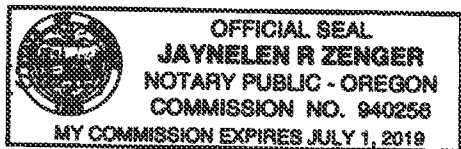
