THIS PATENT ASSIGNMENT is dated 30 September, 2015 and made between:

- (1) **ASTRAZENECA UK LIMITED**, a company incorporated in England and Wales with registered number 03674842, whose registered office is at 2 Kingdom Street, London W2 6BD, England ("**AstraZeneca UK Limited**"); and
- (2) **ASTRAZENECA AB**, a company incorporated in Sweden with registered number 556011-7482, whose registered office is at SE-151, 85 Södertälje, Sweden ("**AstraZeneca AB**");

(together, being "**AstraZeneca**"); and
- (3) **GENZYME CORPORATION**, a company incorporated in Massachusetts who is headquartered at 500 Kendall Street, Cambridge, MA 02142 (the "**Purchaser**").

BACKGROUND:

- (A) AstraZeneca UK Limited and AstraZeneca AB own the Patents (as defined below).
- (B) Under the terms of the Asset Purchase Agreement (as defined below), AstraZeneca UK Limited has agreed to sell, transfer, convey, assign and deliver the Patents to the Purchaser on the terms and subject to the conditions set forth in this Patent Assignment.

IT IS AGREED that:

1 DEFINITIONS AND INTERPRETATION

- 1.1 The definitions and rules of expression and interpretation in the Asset Purchase Agreement shall apply in this Patent Assignment except where expressly stated to the contrary and, in this Patent Assignment, the following expressions shall have the following meanings:

Asset Purchase Agreement the Asset Purchase Agreement between AstraZeneca UK Limited and Purchaser, dated 24 July, 2015, as amended, and relating to the sale of the Caprelsa® product, brand and associated assets; and

Patents means the following rights in the Territory: (i) granted patents that are used or were used exclusively in connection with the Product, in each case that are owned

by AstraZeneca or its Affiliates at Completion, including but not limited to those listed in the schedule to this Patent Assignment, in each case, which are in existence at Completion; (ii) patent applications that are used or were used exclusively in connection with the Product, in each case that are owned by AstraZeneca or its Affiliates at Completion, including but not limited to those in the schedule to this Patent Assignment, in each case, which are in existence at as Completion; (iii) any continuation applications, continuation-in-part applications, divisional applications or similar applications relating to any patent applications referred to in (ii) above and any national or international patent applications anywhere in the world claiming priority from such patent applications; (iv) any parent applications from which the granted patents referred to in (i) above or from which the patent applications referred to in (ii) or (iii) above directly or indirectly derive or claim priority and any continuation applications, continuation-in-part applications or similar applications relating to such applications that claim priority directly or indirectly to such patent applications; and (v) any patents issuing from any of the applications referred to in (ii), (iii), (iv) and (v) above; in relation to any patents falling within (i) and patents issuing from the patent applications referred to in (ii), (iii), (iv) and (v) above, any re-examinations, reissues restorations, or renewals thereof and any extensions of the exclusivity granted in connection with such patents, including extensions granted under the US Drug Price Competition and Patent Term Restoration Act 1984 and the EC Supplementary Protection Certificate Regulation (Council Regulation (EEC) No. 1768/92) and any legislation amending, replacing or implementing the foregoing.

Territory

means any country or territory in the world except Brazil.

2 ASSIGNMENT

2.1 Subject to clause 2.2, pursuant to and for the consideration set out in Clause 3 of the Asset

Purchase Agreement, AstraZeneca hereby sells, transfers, conveys, assigns and delivers to Purchaser, its successors, legal representatives, and assigns all right, title and interest in and to the Patents, and in and to all and any inventions disclosed in the Patents and Purchaser hereby purchases and accepts from AstraZeneca the Patents, including:

- (a) in respect of any and each application in the Patents:
 - (i) the right to claim priority from and to prosecute and obtain grant of patent; and
 - (ii) the right to file divisional applications, continuations, continuations-in-part, renewal applications, design applications, provisionals, converted provisionals, continued prosecution applications, patent of addition applications, confirmation applications, validation applications, utility model applications or similar applications relating to any such application in the Patents based thereon and to prosecute and obtain grant of patent on each and any such application;
- (b) in respect of each and any invention disclosed in the Patents, the right to file an application, claim priority from such application, and prosecute and obtain grant of patent or similar protection in or in respect of any country or territory in the world;
- (c) the right to extend to or register in, or in respect of, any country or territory in the world each, and any of the Patents, and each and any of the applications comprised in the Patents or filed as aforesaid, and to extend to or register in or in respect of any country or territory in the world any patent or like protection granted on any of such applications;
- (d) the entitlement to any patents granted pursuant to any of the applications comprised in the Patents or filed as aforesaid; and
- (e) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Patents or any patents granted on any of the applications comprised in the Patents or filed as aforesaid, whether occurring before, on or after the date of this Patent Assignment.

2.2 Clause 2.1 of this Patent Assignment is subject to any matter, circumstance or information set out in any Disclosed Information in the Seller Disclosure Letter.

3 RECORDATION

3.1 Purchaser hereby authorizes the United States Commissioner of Patents and Trademarks

and, as appropriate, the respective patent office or other Governmental Authority in each jurisdiction other than the United States, to record this Patent Assignment.

4 GOVERNING LAW AND JURISDICTION

4.1 Governing law

This Patent Assignment and any issues, disputes or claims arising out of or in connection with it (whether contractual or non-contractual in nature, including claims in tort or for breach of any statute or Applicable Law) shall be governed by and construed in accordance with English law.

4.2 Jurisdiction

Each party irrevocably submits to the exclusive jurisdiction of the English courts to settle any dispute which may arise under or in connection with this Patent Assignment or the legal relationships established by this Patent Assignment.
