Further, we agree that we will communicate to Klean Kanteen, Inc., or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Klean Kanteen, Inc., make all rightful oaths, and generally do everything possible

to aid Klean Kanteen, Inc., and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
