**ARTICLES OF AMENDMENT
OF
QMOTION INCORPORATED**


Pursuant to Sections 607.1001 and 607.1006 of the Florida Business Corporation Act, QMotion Incorporated, a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The name of the Corporation is QMotion Incorporated.
2. The original Articles of Incorporation were filed on October 21, 2010 and the Corporation was assigned document number P10000086617.
3. The Articles of Incorporation are hereby amended to change the name of the Corporation by amending and restating the first sentence of Article I to read as follows: "The name of the Corporation is Current Products Corp."
4. The foregoing amendment was proposed and recommended by the Board of Directors and adopted by the sole shareholder of the Corporation on the 23rd day of December, 2015, in accordance with the provisions of Section 607.1003 of the Florida Business Corporation Act.
