ASSIGNOR further covenants and agrees that she will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect Assignee's rights


in and to the Invention and any and all United States and/or foreign Letters Patent that may be granted on said Application or otherwise for said Invention.
