CONFIRMATORY PATENT ASSIGNMENT

WHEREAS, **Knowles Electronics Asia PTE. WHEREAS, the parties wish to ratify and confirm the assignment and transfer of the entire right, title and interest in and to any and all rights and privileges regarding the Invention.

This assignment includes, without limitation, any continuations, divisions, continuations-in-part, reissues, reexaminations, extensions or foreign equivalents of the Patent Applications, and includes the subject matter of all claims that may be obtained therefrom, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for **Assignee’s** own use and enjoyment, and for the use and enjoyment of **Assignee’s** successors, assigns, or other legal representatives, as fully and entirely

as the same would have been held and enjoyed by **Assignor** if this Assignment had not been made.

Assignor authorizes and requests that the Patent Office officials in the United States and in any and all foreign countries to issue any and all Letters Patent when granted solely to **Knowles IPC (M) Sdn. Bhd.**, for its sole use and that of its successors, assigns and legal representatives.

Assignor will provide its cooperation to enable the **Assignee** to enjoy the foregoing right, title, and interest to the fullest extent. Upon request and at the expense of the **Assignee**, **Assignor** agrees to execute all papers, take all rightful oaths, testify in all legal proceedings including patent prosecutorial actions and infringement actions, and do all other such acts which may be necessary, desirable, or convenient for securing and maintaining patents on the foregoing Invention or for perfecting title thereto in the **Assignee**.
