ASSIGNMENT

WHEREAS I, Robert Dale Busser of 4368 Borland Street, West Bloomfield, MI 48323 (hereinafter referred to as "ASSIGNOR"); have invented certain new and useful improvements in:

SYSTEM FOR DETERMINING A DISCHARGE POWER LIMIT VALUE AND A CHARGE POWER LIMIT VALUE OF A BATTERY CELL
