NOW, THEREFORE, in consideration of the execution of this Assignment, the receipt and sufficiency of which is hereby acknowledged, the Executrix does hereby irrevocably assign, donate, transfer, convey and set over to the Beneficiary the full and exclusive right, title and interest in and to (i) the patents, patent applications, designs and registered community designs set forth in **Schedule A** hereto, (ii) any applications for patents on any inventions or designs described in any of the foregoing patents, patent applications, designs and registered community designs, and all patent applications relating thereto which have been or shall be filed in the United States, its territorial possessions and/or any foreign countries, (iii) any and all applications claiming the benefit of the filing date or claiming priority, directly or indirectly, from any of the foregoing, including without limitation any and all divisional applications, continuation applications, continuation-in-part applications, reissue applications, reexaminations, extensions and corresponding international, regional, national and other foreign applications, (iv) any and all patents issuing or reissuing, directly or indirectly, from any of the foregoing, and (v) all claims for damages or injunctive relief by reason of infringement of any of the foregoing, with the right to sue for past infringement and to collect damages for the same for its own use and benefit and for the use and benefit of its successors, assigns and other legal representatives (all of the foregoing hereafter referred to collectively as the "Subject Property").

AND, the Executrix hereby confirms and acknowledges that the Beneficiary shall have sole and absolute discretion with respect to filing, prosecution, maintaining and enforcement of the Subject Property.

AND, the Executrix does hereby authorize and requests that patents issued from any of the foregoing patent applications be issued to the Beneficiary, as the assignee of the entire right, title and interest thereto.
