This Agreement shall be effective as of August 1<sup>st</sup>, 2014.



10. **Term and Termination.** This Agreement shall expire on the expiration date of the last of the Patents and Patent Rights to expire. Expiration, however, shall not affect the provisions of Sections 9 (Secrecy) and 11 (Assignment) and shall not relieve BCS to make any outstanding payments due according to Section 3.
11. **Assignment.** Neither Party shall assign this Agreement or any part hereof or any interest herein to any third party (*i.e.*, any party other than an Affiliate of the referenced Party), without the written approval of the other Party; provided, however, that either Party may assign this Agreement without such consent in the case of a merger, consolidation, change in control or sale of all or substantially all of the assets (or of the assets related to the performance of this Agreement) of the Party seeking such assignment or transfer where such transaction relates to the business covered by this Agreement and the resulting entity assumes all of the obligations under this Agreement.
12. Should provisions of this Agreement be or become legally invalid, such invalidation shall not affect the validity of the remaining provisions of this Agreement. In place of the invalid provision, an appropriate provision shall apply which, as far as legally possible, most closely approximates the intention of the Parties.
13. The Parties acknowledge that this Agreement, together with any exhibits attached hereto, sets forth the entire agreement and understanding of the Parties as to the subject matter of this Agreement, and supersedes all prior and contemporaneous discussions, agreements and writings in respect to the subject matter of this Agreement, REDACTED  
REDACTED Amendments and additions to this Agreement, including this clause, shall only be valid if made in writing and duly signed by the Parties hereto.
- 14 This Agreement shall be governed by and construed according to the substantive laws of Germany without recourse to its conflict of laws rules.
15. This Agreement is executed in the English language in two execution copies, both regarded as originals.



