CONFIRMATORY ASSIGNMENT

THIS ASSIGNMENT is made this 12 day of DECEMBER 2014

BETWEEN WHITE, William John of 26 Broad Walk, Hockley, Essex, SS5 5DD, United Kingdom, who is a British citizen (hereinafter called "the Assignor", which expression where the context so requires shall include his successors in title) of the one part

AND KEYMED (MEDICAL AND INDUSTRIAL EQUIPMENT LIMITED) whose registered office is at Keymed House, Stock Road, Southend-on-Sea, Essex, SS2 5QH (hereinafter called "the Assignee" which expression where the context so requires shall include its successors in title) of the other part

RECITALS :

- (A) The Assignor claims to be the inventor of the inventions (hereafter called "the Inventions") described in the specification accompanying the application for a patent details of which are set out in the Schedule hereto (hereinafter called "the Application");
- (B) In accordance with a contract of employment between the Assignor and the Assignee and in accordance with Section 39(1) UK Patents Act 1977, all rights, title, interest and property in the Application and the Inventions have passed from the Assignor to the Assignee;
- (C) The Assignor wishes to confirm the Assignee's ownership of all rights, title, interest and property in the Application and the Inventions and to transfer to the Assignee any and all of that which may not previously have been passed to the Assignee under the following terms;

OPERATIVE PROVISIONS :

1. In consideration of the sum of £10 paid by the Assignee to the Assignor, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby confirms or assigns the following to the Assignee:
 - i) all of the Assignor's rights, title, interest and property in the Inventions and the Application, free from all licenses, charges and other encumbrances, with full title guarantee;
 - ii) the right to file further applications, including divisional applications and continuations, to obtain patents in respect of the whole or any part or parts of or improvements to the Inventions in the United Kingdom and throughout the world ("Further Applications") and/or to obtain other forms of protection to the intent that those Further Applications and other forms of protection shall be in the name of and shall vest in the Assignee;

- iii) the full and exclusive benefit of the Inventions, Application and Further Applications, and other forms of protection and all rights, privileges and advantages appertaining thereto, together with the right to obtain any extensions and supplementary protection certificates;
- iv) the right to recover and to bring proceedings to recover damages and/or to obtain other remedies in respect of infringement of the Application, Further Applications, any patent granted on the Application and Further Applications, and other forms of protection relating to the Inventions whether committed before or after the date of this Assignment;
- v) the right to claim priority from the Application or Further Applications under the terms of the International convention and any treaties; and
- vi) the right to make improvements to the Inventions and to apply for and obtain patents or other forms of intellectual property protection in the name of the Assignee in respect of the improvements which shall vest in the Assignee;

to the intent that the Inventions, Application, Further Applications and other forms of protection and all rights, privileges and advantages appertaining thereto shall be in the name of and shall vest in the Assignee TO HOLD the same unto the Assignee absolutely.

2. At the request and cost of the Assignee, the Assignor will execute and sign all such instruments, applications, deeds, documents and do all such acts and things as may be reasonably required by the Assignee to enable the Assignee or its nominee to:
 - (a) enjoy the full and exclusive benefit of the Inventions and the Application and of the property rights hereby assigned;
 - (b) fully and effectively vest the same in the Assignee; and
 - (c) formally register the Assignee's title in the same at the relevant Patent Office.
3. The Assignor hereby covenants:
 - (i) that he has not assigned or agreed to assign to any person firm or company or otherwise encumbered the Inventions or any other part of the property and rights hereby assigned;
 - (ii) that he has not disclosed and will not hereafter disclose the Inventions or any information whatsoever concerning the same to any person firm or company other than the Assignee or as it shall direct or permit; and
 - (iii) that he will give to the Assignee all information in his possession or in his power relating to the Inventions and the method of using or employing the same as the Assignee shall require.
4. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto,


their respective successors and assigns as well as any subsidiary companies of the parties hereto.

5. The parties will co-operate and consult with one another in good faith, if necessary in the future to carry out the intent of this agreement.
6. This Agreement shall be governed by and construed in accordance with the laws of England & Wales and the parties for this purpose hereby submit to the exclusive jurisdiction of the Courts of England & Wales.

IN WITNESS whereof the Assignor has hereunto set his hand and the Assignee has caused these presents to be executed the day and year first before written.




