ASSIGNMENT

Whereas, I/we, Patrick Y. 1. 2. Authorize Assignee to file applications for industrial property protection in any or all countries and regional authorities on any or all of said inventions in my/our name(s) or in the name of Assignee or otherwise as Assignee may deem advisable;

3. Authorize and request the Commissioner for Patents of the United States of America and the empowered officials of all other countries and regional authorities to grant

and issue patents and other forms of industrial property protection to Assignee or transfer all said granted patents and other forms of industrial property protection to Assignee or to another party as the Assignee may direct;
