**ASSIGNMENT**

WHEREAS, we, Ilwhan Park, residing at 1743 Holland Circle, Walnut Creek, California 94597 U.S.A., Venkata Surya Sarva, residing at 44958 Cougar Circle, Fremont, California 94539 U.S.A., and Irene Min Choi, residing at 3 Admiral Drive, #452, Emeryville, California 94608 U.S.A. (hereinafter, individually and collectively the "Assignor"), have invented certain new and useful systems, devices, and methods disclosed and described in a utility application for Letters Patent in the United States ("U.S."), entitled "Arthroplasty System and Related Methods," which can be identified in the United States Patent and Trademark Office ("USPTO") by U.S. Patent Application No. 12/546,545, filed on August 24, 2009 (the "Utility Application") with attorney docket No. 189688/US/2. 

UPON SAID CONSIDERATION, Assignor represents and warrants that Assignor has the right, title, and authority to execute this Assignment and to convey any and all right, title, and interest in the Patent Rights, and that Assignor has not conveyed nor will convey hereafter all or part of the Patent Rights to a third party;

ASSIGNOR HEREBY AUTHORIZES said Assignee, its successors, and assigns, or anyone it may properly designate, to apply for Letters Patent in the U.S. and any and all foreign countries and regions, in its own name if desired, and additionally to claim priority to the filing date of the Utility Application and otherwise take advantage of the provisions of any international conventions.


