ASSIGNMENT

WHEREAS, Carebay Europe Limited, a corporation duly organized under and pursuant to the laws of Malta and having a principal place of business at 57 Tigne Palace, Suite 3, Bisazza Street, Sliema SLM 1643, Malta (hereinafter referred to as "the Assignee"), is desirous of acquiring the entire right, title, and interest in and to the inventions; the entire right, title, and interest in and to the Application; the right to file applications on the inventions; and the entire right, title, and interest in and to any applications, including provisional and non-provisional applications for Letters Patent of the United States or other countries, claiming the benefit of and/or priority to the Application, and in and to any Letters Patent or Patents, United States or foreign, to be obtained therefor and thereon.

These rights, titles, and interests include, but are not limited to: all rights to and privileges in the Application, related already-filed and yet-to-be-filed applications (including but not limited to utility applications, continuation applications, continuation-in-part applications, divisional applications, and reissue applications), and any and all Letters Patent or Patents that may be granted in the United States of America or other countries for said inventions; all rights of priority arising from the Application identified above; and all rights and privileges under any and all forms of protection, including Patents,

that may be granted in the United States of America and other countries for the inventions. All of the above-mentioned rights, titles, and interests are to be held and enjoyed by the Assignee, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, to the full end of the term or terms for which Letters Patent or Patents may be granted as fully and entirely as the same would have been held and enjoyed by the Assignors had this sale, assignment, transfer, and set over not been made;

AND for the same consideration, the Assignor authorizes the Assignee to make application for such protection in its own name and maintain such protection in any and all countries foreign to the United States, and to invoke and claim for any application for patent or other form of protection for said inventions, without further authorization from the Assignors, any and all benefits, including the right of priority provided by any and all treaties, conventions, or agreements;



AND the Assignor hereby authorizes and requests that Piedmont Intellectual Property insert in the spaces provided above the filing date, attorney's docket number and other identifying indicia of the Application if absent;

AND the Assignor hereby requests that the Commissioner of Patents issue any and all said Letters Patent of the United States to the Assignee as the Assignee of said inventions, the Letters Patent to be issued for the sole use and behalf of the Assignee, its successors, legal representatives, and assigns.
