INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (“*IP Assignment*”), dated as of June 30, 2015, is entered into by and between Niteo Products, LLC, a Delaware limited liability company (“*Assignee*”), on the one hand, and Ashland, Inc., a Kentucky corporation (“*Ashland*”), and Ashland Licensing and Intellectual Property LLC, a Delaware limited liability company (together with Ashland, collectively, “*Assignor*”), on the other hand.

WHEREAS, pursuant to that certain Asset Purchase Agreement (the “*Purchase Agreement*”), dated as of April 3, 2015, by and between Ashland and Assignee, Ashland agreed to sell, convey, assign, transfer and deliver to Assignee its entire right, title and interest in and to all of the Intellectual Property Rights (as defined in the Purchase Agreement), including the intellectual property set forth on Schedule 1 attached hereto (collectively, the “*Acquired Intellectual Property*”). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Patents and Patent Applications. Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee, in accordance with the Purchase Agreement, all right, title and interest, in and to those patents and patent applications (including reissues, provisionals, divisions, continuations, continuations-in-part, reexaminations and extensions thereof (U.S. and foreign)) included in the Acquired Intellectual Property, including those listed on Schedule 1, together with the right to obtain patent or equivalent protection therein throughout the world, and the right to sue and recover any and all damages and profits, and any and all other remedies, for past, present, or future infringements or violations thereof, all in Assignee’s sole name.

2. Trademarks, Service Marks and Domain Names. Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee, in accordance with the Purchase Agreement, all right, title and interest in and to those domain names, trade names, trademarks, service marks, logos and trade dress (including any unregistered common law names or marks, issued registrations or pending applications (U.S. and foreign) for such domain names, trade names, trademarks, service marks, logos and trade dress, applications therefor, and all renewals, modifications and extensions thereof) together with the goodwill connected with the use of and symbolized by such domain names, trade names, trademarks, service marks and trade dress, which are included in the Acquired Intellectual Property, including those listed on Schedule 1, together with the goodwill of the business that is symbolized by such trademarks, including renewal rights therein, the right to obtain registrations of such trademarks throughout the world, and the right to sue and recover any and all damages and profits, and any and all other remedies, for past, present or future infringements or violations thereof, all in Assignee’s sole name.

3. Copyrights. Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee, in accordance with the Purchase Agreement, all right, title and interest in and to all copyrights, whether or not registered or registrable, for any works of authorship, expressions or designs, used exclusively in the Business (as defined in the Purchase Agreement) and included in the Acquired Intellectual Property, including those listed on Schedule 1, together with the renewal rights therein, the right to obtain registrations in the United States and throughout the world, and the right to sue and recover any and all damages and profits, and any and all other remedies, for past, present or future infringements or violations thereof, all in Assignee's sole name.

4. Trade Secrets. Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee, in accordance with the Purchase Agreement, all right, title and interest in and to all trade secrets, formulations, processes, procedures, techniques, technical information, specifications, operating and maintenance manuals, drawings, software, technical data, databases, discoveries, works of authorship, designs, technology, rights in research and development, inventions for which patents have not been issued or applied, modifications, extensions, improvements and other confidential or proprietary information, in each case that relate exclusively to the Business (as defined in the Purchase Agreement) or which are included in the Acquired Intellectual Property, including those listed on Schedule 1, together with the right to sue and recover any and all damages and profits or seek injunctive relief, and any and all other remedies, for past, present or future misappropriations or violations thereof, all in Assignee's sole name.

5. Software. Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee, in accordance with the Purchase Agreement, all right, title and interest in and to those computer software programs, including all source code, object code, and documentation related thereto that related exclusively to or are otherwise exclusively used in the Business (as defined in the Purchase Agreement) or which are included in the Acquired Intellectual Property, including those listed on Schedule 1, together with the right to sue and recover any and all damages and profits or seek injunctive relief, and any and all other remedies, for past, present or future misappropriations or violations thereof, all in Assignee's sole name.

5. IP-Related Contracts. Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee, in accordance with the Purchase Agreement, all right, title and interest in and to those Contracts listed on Schedule 1 that relate to the forgoing Sections 1 through 4, together with the right to sue and recover any and all damages and profits or seek injunctive relief, and any and all other remedies, for past, present or future misappropriations or violations thereof, all in Assignee's sole name.

6. Further Undertakings. Each party hereto shall, from time to time, but without further consideration, cooperate with the other party in any reasonable action requested of such party in order to effectuate, carry out or fulfill such parties' intent and/or the obligations hereunder, including, without limitation, the execution of any instruments and papers that are necessary or desirable to consolidate, confirm, vest and/or record Assignee's full and complete ownership of the Acquired Intellectual Property with, for example, the United States Patent and Trademark Office; it being understood

that no party hereto, nor any of its respective Affiliates, shall be required to expend money, commence any litigation or offer or grant any accommodation (financial or otherwise) to any third party in connection with this Section 6.

7. Entire Agreement. This IP Assignment is subject to all of the representations, warranties, covenants and indemnities relating to the Acquired Intellectual Property set forth in the Purchase Agreement, all of which are incorporated herein by reference. In the event of any conflict or inconsistency between the terms of this IP Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall prevail.

8. Binding Assignment. This IP Assignment shall inure to the benefit of and be binding upon the parties hereto and their respective Affiliates, successors and permitted assigns. Nothing in this IP Assignment, express or implied, is intended to confer upon any Person other than Assignor, Assignee or their respective Affiliates, successors and permitted assigns, any rights or remedies under or by reason of this IP Assignment.

9. Governing Law. This IP Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, without regard to its principles of conflict of laws. Any Proceeding arising out of or related to this IP Assignment shall be instituted exclusively in the federal and state courts located in St. Louis, Missouri. Each party hereto irrevocably submits to the exclusive jurisdiction of such courts in any such Proceeding.

10. Counterparts. This IP Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same agreement.

11. Interpretation. In the interpretation of this IP Assignment, except where the context otherwise requires, (a) "including" or "include" does not denote or imply any limitation, (b) "or" has the inclusive meaning "and/or," (c) "and/or" means "or" and is used for emphasis only, (d) the singular includes the plural, and vice versa, and each gender includes each other gender, (e) headings are only for reference and are not to be considered in interpreting this IP Assignment, (f) "Section" and "Article" refer to sections and articles of this IP Assignment, unless otherwise stated in this IP Assignment, (g) "Schedule" references are to schedules hereto and (h) "party" or "parties" refers to the parties hereto, unless the context indicates otherwise.
