2. Assignor warrants that it has not granted any rights in the Design Patents that are inconsistent with this Assignment, and further acknowledges and agrees that Assignor does not retain any reversionary or other interest in and to the Design Patents.

3. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any officers of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of intellectual property protection or applications as aforesaid, to issue any and all letters patent on such inventions resulting from the Design Patents, or any continuations-in-part, continuations, divisions, substitutes, reissues, reexamination certificates, or extensions thereof, to Assignee, as assignee of Assignor's entire interest therein.

4. Assignor shall provide to Assignee, its successors, assigns or other legal representatives, cooperation and assistance at Assignee's request and expense (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths and other documentation as may be reasonably required) to perfect and vest title in the Design Patents in Assignee or Assignee's successors and assigns.
