ASSIGNMENT

- The Assignee hereby accepts such assignment.

At the request and cost of the Assignee, the Assignor shall assist the prosecution of said Corresponding Applications to grant and will assist the defence of any proceedings by way of intervention or in opposition to the Corresponding Applications or grant of Corresponding Patents and will execute all such deeds and documents and do all such acts as may be necessary or desirable formally to register this Assignment at the Regional and National Patent Offices for the United States of America and to render this Assignment effective under the national law of the United States of America in the Applications and to procure the grant of the Corresponding Patents pursuant to the Corresponding Applications.
