Omnicell also hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of invention that may be granted upon any of the Patent Rights in the name of MV Circuit, as the assignee of the entire interest therein.

The terms and conditions of this Assignment, which are subject to additional terms and conditions stated in the parties' Settlement and Assignment agreement, shall inure to the benefit of MV Circuit, its successors, assigns, and other legal representatives, and shall be binding upon Omnicell its successors, assigns, and other legal representatives.
