SALE



2. Nothing contained in this Bill of Sale is intended to provide any rights to the Seller beyond those rights expressly provided to the Seller in the Purchase Agreement. Nothing contained in this Bill of Sale is intended to impose any obligations or other Liabilities on the Purchaser beyond those obligations and other Liabilities expressly imposed on the Purchaser in the Purchase Agreement. Nothing contained in this Bill of Sale is intended to limit any of the rights or remedies available to the Purchaser under the Purchase Agreement. If there is any inconsistency between the Purchase Agreement and this Bill of Sale, the Purchase Agreement will control.
3. This Bill of Sale shall be governed by and construed and interpreted in accordance with the laws of the State of Delaware irrespective of the choice of laws principles of the State of Delaware, as to all matters, including, without limitation, matters of validity, construction, effect, enforceability, performance and remedies and in respect of the statute of limitations or any other limitations period applicable to any claim, controversy or dispute.
4. This Bill of Sale may be executed in counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement. The exchange of a fully executed Bill of Sale (in counterparts or otherwise) by facsimile or

electronic delivery in .pdf format shall be sufficient to bind the parties to the terms and provisions of this Bill of Sale.
