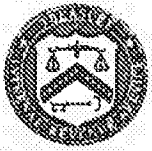

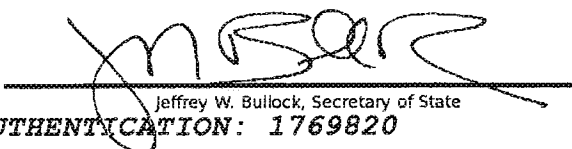

Tellabs Operations, Inc. (the "Company"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, **DOES HEREBY CERTIFY THAT:**

FIRST: The Board of Directors of the Company, by unanimous written consent of its members, a copy of which has been filed with the minutes of the Company, adopted the following resolution proposing an amendment to the Certificate of Incorporation of the Company:

RESOLVED, that Article First of the Certificate of Incorporation of the Company be amended to read in its entirety as follows:
