ARTICLES OF CONVERSION

Pursuant to Section 2.15 of the Texas Revised Limited Partnership Act (the "Act"), the undersigned, Robert Vanman, President of Digital Enforcement Technologies Group, LLC, as the general partner of Enforcement Video, LP, a Texas limited partnership (the "Converting Entity"), does hereby certify as follows:

1. The name of the Converting Entity is Enforcement Video, LP. The Converting Entity is a Texas limited partnership.

2. The name of the Converted Entity (so called herein) shall be Enforcement Video, LLC. The Converted Entity shall be a Texas limited liability company.

3. A plan of conversion (the "Plan") with respect to the conversion of the Converting Entity into the Converted Entity has been duly authorized by all action required by the laws under which the Converting Entity was formed and by its constituent documents.

4. 6. The Converted Entity shall be liable for the payment of all required franchise taxes that have not been paid by the Converting Entity.
