Assignor hereby assigns, sells, and transfers 100% undivided interest in said Invention, said application, including any non-provisionals, divisionals, continuations, and continuations-in-part thereof, reissues, reexaminations, extensions and substitutions, and in and to any and all Letters Patent of the United States, and countries foreign thereto, Convention rights, and other benefits accruing or to accrue to it with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto, unto said Assignee;


