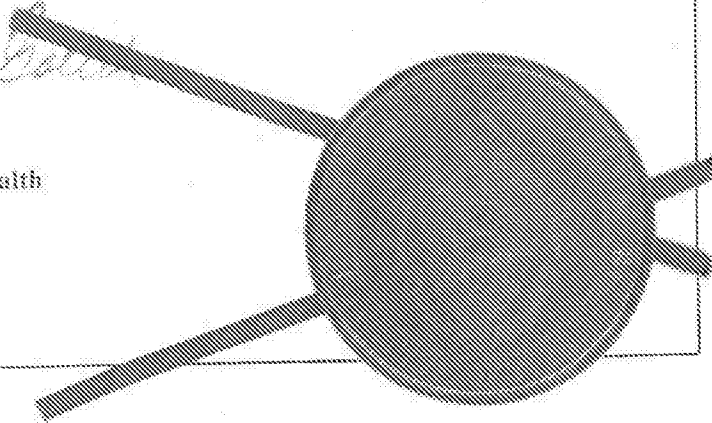

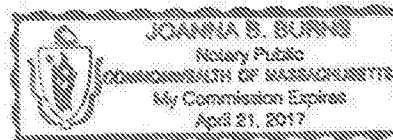

Patent Assignment Agreement

This assignment agreement (the "Assignment") is made on 27th February 2015

between:

- (1) NOVARTIS PHARMA AG, a corporation incorporated in Switzerland, having its registered office at Lichtstrasse 35, 4056 Basel, Switzerland, and
 - (2) NOVARTIS VACCINES AND DIAGNOSTICS, Inc., a company incorporated under the laws of Delaware, with an address at 350 Massachusetts Avenue, Cambridge, MA 02139, and
 - (3) NOVARTIS AG, a corporation incorporated in Switzerland, having its registered office at Lichtstrasse 35, 4056 Basel, Switzerland (the "Designee"),
- together the "parties" and each a "party".

Whereas:

- (A) Under that certain agreement dated 1 April 2007, Novartis Vaccines and Diagnostics, S.r.l. has transferred all right, title, and interest in the PAT051491 Patents (as defined below) to Novartis Pharma AG (the "2007 Agreement") and the 2007 Agreement was effective to transfer all right, title, and interest in the PAT051491 Patents to Novartis Pharma AG in certain countries in which the PAT051491 Patents have been prosecuted;
- (B) Under an assignment dated July 15, 2009 (the "2009 Assignment"), executed because of a change of inventorship in the PAT051491 Patents (as defined below), Novartis Vaccines and Diagnostics, Inc. is a co-owner of the PAT051491 Patents in certain countries;
- (C) Novartis Pharma AG and Novartis Vaccines and Diagnostics, Inc. now seek to designate Designee to receive and hold title to their rights in the PAT051491 Patents (as defined below), and agree to transfer title in and to the PAT051491 Patents to Designee; and
- (D) The PAT051491 Patents (as defined below) have been prosecuted and developed in the intervening years, and the parties desire to clarify and summarize the assets transferred under the 2007 Agreement such that all right, title and interest vest with Designee.

It is agreed as follows:

1. Interpretation

1.1 In this Assignment:

"PAT051491 Patents" means the patents and patent applications listed in Schedule I.

2 **Assignment**

In consideration of the sum of one Euro (€1), receipt of which is hereby acknowledged by Novartis Pharma AG and Novartis Vaccines and Diagnostics, Inc., Novartis Pharma AG and Novartis Vaccines and Diagnostics, Inc. hereby assign to the Designee all of their title in and to the PAT051491 Patents together with all rights, privileges and advantages thereto, including, without limitation, the right to take proceedings and recover damages and obtain all other remedies in respect of past infringements thereof, and the right to claim priority from any patent application therein, to hold unto the Designee absolutely for the full term of the PAT051491 Patents.

3 **Exclusion of Warranties**

Novartis Pharma AG and Novartis Vaccines and Diagnostics, Inc. grant such title as they may have in the PAT051491 Patents, but exclude any and all warranties (express and/or implied) in relation to the PAT051491 Patents, other than those set out in the 2007 Agreement and in the 2009 Assignment.

4 **Further Assurance**

Novartis Pharma AG and Novartis Vaccines and Diagnostics, Inc. shall execute all such documents and render all such assistance as may be reasonably required for the purpose of giving full effect to this Assignment, including any documents required to clarify and perfect the chain of title of any of the PAT051491 Patents.

5 **Entire Agreement**

This Assignment is subordinate to the 2007 Agreement and modifies it to the extent that title to the PAT051491 Patents is hereby transferred to Designee. Other than this modification, any other term of this Assignment which is inconsistent with the 2007 Agreement is not applicable to the extent of the inconsistency. Novartis Pharma AG and Novartis Vaccines and Diagnostics, Inc. acknowledge that they have not been induced to enter into this Assignment by any representation, warranty or undertaking not expressly incorporated into the 2007 Agreement.

6 **Variation**

No variation of this Assignment shall be effective unless in writing and signed by or on behalf of all parties.

7 **Invalidity**

- 7.1 If any provision in this Assignment shall be held to be illegal, invalid or unenforceable, in whole or in part, such provision or part shall to that extent be

deemed not to form part of this Assignment but the legality, validity or enforceability of the remainder of this Assignment shall not be affected.

- 7.2 If any illegal, invalid or unenforceable provision would be legal, valid and enforceable if some part of it were deleted or modified, the provision shall apply with whatever deletion or modification is necessary to give effect to the commercial intention of the parties.

8 **Governing Law and Submission to Jurisdiction**

- 8.1 This Assignment and any non-contractual obligations arising out of it shall be governed by, and construed in accordance with, the laws of Switzerland.

- 8.2 The parties irrevocably agree that the courts of Switzerland shall have exclusive jurisdiction to settle any dispute, whether contractual or non-contractual, which may arise out of or in connection with this Assignment.
