ASSIGNMENT

WHEREAS, Ferdinand Felder, residing at Nordstr. 194, 8037 Zurich, Switzerland; Matthias Fill, residing at Frobelsstr. 20, 8032 Zurich, Switzerland; Oliver Meier, residing at Berninastr. 9, 8057 Zurich, Switzerland; and Hans Zogg, residing at Weiheracherstr. 1, 8114 Danikon, Switzerland (hereinafter referred to as "Assignors"), have invented certain new and useful improvements in a HERMETICALLY SEALED CONTAINER FOR LASER DEVICE, for which a national stage application for United States Letters Patent was filed on even date herewith, and based on International PCT Patent Application No. PCT/EP2014/071907, filed October 13, 2014, claiming priority on European Patent Application No. 13188545.1, filed October 14, 2013.

Assignors hereby authorize and request the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said Assignee as the owner of the entire right, title and interest in and to the same, for the sole use and behoof of said Assignee, its successors and assigns.

FURTHER, Assignors agree to communicate to said Assignee or its representatives any facts known to Assignors respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all utility, divisional, continuation, continuation-in-part, substitution, renewal, and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Assignee, make all rightful oaths and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
