ASSIGNMENT

WHEREAS, Robert R. Bushey, a citizen of the United States of America, residing at 1117 Stillwell Ridge, Cedar Park, Texas 78613; John M. Martin, a citizen of the United States of America, residing at 6411 Paintbrush Hollow, Austin, Texas 78750; and Benjamin A. AND said Assignors hereby covenant and agree, for both the Assignors and the Assignors' legal representatives, that the Assignors will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and in the prosecution of any interference which may arise involving said invention, or any such patent application or patent; and that the Assignors will execute and deliver to the Assignee to carry out the terms of this Assignment. Assignors authorize the attorney or agent who files the patent application first referenced above to fill in the U.S. Application Serial No. and filing date above, if required.

AND said Assignors authorize and request the Commissioner of Patents to issue Letters Patent on said application, and on all divisions and continuations thereof, to said Assignee, its assigns and legal representatives, in accordance with the terms of this Assignment.
