(h) all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the patent(s) or patent application(s) and/or any item in any of the foregoing categories, including, without limitation, all causes of action and other enforcement rights for

- (i) damages,
- (ii) injunctive relief, and
- (iii) any other remedies of any kind

for past, current, and future infringement; and

- (i) all rights to collect royalties and other payments under or on account of the patent or patent application and/or any item in any of the foregoing categories.

Assignor hereby authorizes the respective patent office or governmental agency in each jurisdiction to make available to Assignee all records regarding the Patent Assets.

Assignor will assist Assignee in any way, but at Assignee's expense, to perfect Assignee's rights in the Patent Assets.
