ASSIGNMENT

Whereas, Evemarie Hamann, Joachim Kiesekamp, Sven K. H. Thiele, and Daniel Heidenreich, hereinafter called the "Assignors", made the invention described in PCT Patent Application No. PCT/EP2013/070227 filed September 27, 2013, and United States Patent Application titled "Low Vinyl Bond Modified Elastomeric Copolymers", executed by Assignors on the same date as, or on a date prior to, this Assignment;

Now, therefore, in consideration of valuable and legally sufficient consideration, the receipt of which by the Assignors from the Assignee is acknowledged, the Assignors have sold, assigned and transferred, and by these presents sell, assign and transfer to the Assignee, the entire right, title and interest for the United States in the invention and the patent application identified above, and any patents that may issue in the United States; with the entire right, title and interest in the invention and all patent applications and patents issuing therefrom in all countries foreign to the United States, including the full right to claim for any such application all benefits and priority rights under any convention; with the entire right, title and interest in all continuations, divisions, renewals and extensions of any of the patent applications and patents defined above; with the right to recover all damages, including, but not limited to, a reasonable royalty, by past, present, or future infringement or any other violation of patent or patent application rights; to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents. The Assignors sell, assign, and transfer the entire right, title and interest to the Assignee as of the day of filing the application identified above.

The Assignors covenant and agree, for both the Assignors and the Assignor's legal representatives, that the Assignors will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee like exclusive title in all such other patent applications and patents; and in the prosecution of any interference which may arise involving the invention, or any such patent application or patent; and that the Assignors will execute and deliver to the Assignee all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.




