

TO THE
CERTIFICATE OF INCORPORATION
OF

(Pursuant to Section 242 of the Delaware General Corporation Law)

It is hereby certified that:

1. The name of the corporation is Hitachi Power Systems America, Ltd. (the "Corporation").
2. The Corporation filed its Certificate of Incorporation with the Delaware Secretary of State on February 4, 2005.
3. The Certificate of Incorporation of the Corporation is hereby amended as follows:

By deleting Article FIRST in its entirety and replacing it with the following:

"FIRST: The name of the corporation is Mitsubishi Hitachi Power Systems America – Energy and Environment, Ltd. (the "Corporation")."

4. This Certificate of Amendment to the Certificate of Incorporation of the Corporation was duly adopted pursuant to the provisions of Section 242 of the Delaware General Corporation Law.
5. This Certificate of Amendment shall be effective as of February 1, 2014.
