SAP AG

(formerly: SAP Aktiengesellschaft Systeme, Anwendungen, Produkte in der Datenverarbeitung – in english language called "Systems, Applications, Products in Data Processing") was entered in the Commercial Register HRB 269-Wie at the Heidelberg Municipal Court on August 4, 1988, as a stock corporation following conversion from its previous legal form (limited liability company) and is still entered in the Commercial Register as such.

The change of the name from "SAP Aktiengesellschaft Systeme, Anwendungen, Produkte in der Datenverarbeitung" (in english language called "Systems, Applications, Products in Data Processing") to "SAP AG" was entered in the above said Commercial Register at June 9, 2005. 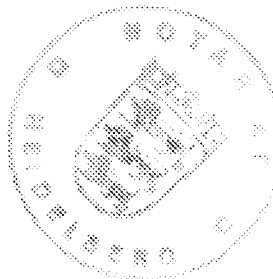
