Assignor shall provide all reasonable assistance to enable the Assignee to pursue any claim, action or proceedings relating to the Patents.

4. **Acknowledgement.** Assignor hereby authorizes and requests that the competent authorities record this Assignment, and grant and issue any and all patents included in the Patents to the Assignee as the assignee of all right, title and interest therein.

5. **Representations and Warranties.** Assignor represents and warrants that (a) Assignor has full power and authority to enter into this Assignment, and (b) this Assignment has been duly authorized, executed and delivered by Assignor and constitutes the legal, valid and binding obligation of Assignor, enforceable against it in accordance with the terms hereof.

6. **Successors.** This Assignment shall be binding upon and inure to the benefit of the Parties hereto and to their respective successors and assigns.
