WHEREAS, Assignee is desirous of acquiring the full and exclusive right in and to said Inventions.


NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby sells, assigns and sets over to Assignee the entire right, title and interest for the United States and all other countries in and to said Inventions and the aforesaid patents and applications for patent, including all original, provisional, nonprovisional, divisional, continuation, substitute, reissue and reexamination applications and patents applied for or granted therefor in the United States and all other countries, all rights of priority from the filing of said applications, and all rights for past infringement; the U.S. Commissioner of Patents and Trademarks and all other Patent Offices around the world where the Inventions are filed are hereby authorized and requested to issue all patents on said Inventions or resulting therefrom to said Assignee herein, as assignee of the entire interest therein; and the undersigned for Assignor and Assignor's legal representatives, heirs and assigns does hereby agree and covenant without further remuneration to execute and deliver all divisional, continuation, reissue and other applications for patent on said Inventions and all assignments thereof to said Assignee or its assigns, to communicate to said Assignee or its representatives all facts known to Assignor respecting said Inventions, whenever requested, to testify in any interferences or other legal proceedings in which any of said applications or patents may become involved, to sign all lawful papers, to make all rightful oaths, and to do generally everything necessary to assist Assignee, its successors, assigns and nominees to obtain patent protection for said Inventions in the United States and all other countries, the expenses incident to said applications to be borne and paid by said Assignee.

At Assignee's cost, Assignor hereby agrees to cooperate with Assignee to execute any and all further documents to assign the Inventions and all of the patents and pending patent applications referenced in the annexed *Schedule A*. In the event Assignor is not available to execute such further documents necessary to bring about the purpose of this Agreement, Assignor hereby grants Christoph Gamper a limited *Power of Attorney* to execute any and all such documents on Assignor's behalf, as long as Christoph Gamper remains an officer of Assignee.
