CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION OF LASER
DEVICES, INC.

The undersigned certify that:


1. They are the President and the Secretary, respectively, of Laser Devices, Inc., a California corporation.
2. Article One of the Articles of Incorporation of this corporation is amended to read as follows: The name of this corporation is Steiner eOptics, Inc.
3. The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. This Corporation has only two classes of shares designated respectively "common stock" and "preferred stock." The authorized number of shares of common stock is 1,000,000 shares and the authorized number of shares of preferred stock is 100,000 shares. The initial series of preferred stock of this corporation was designated and known as: "Series A Preferred Stock." The number of shares constituting such initial series of preferred stock was 10,000 shares, all of which have heretofore been redeemed by this Corporation and there were no outstanding shares of preferred stock entitled to vote on the foregoing amendment. The total number of outstanding shares of common stock entitled to vote on the foregoing amendment was 5,903 shares of common stock. The number of shares of common stock of this Corporation voting in favor of the foregoing amendment was 5,903 shares of common stock. The number of shares voting in favor of the foregoing amendment equaled or exceeded the vote required. The percentage vote required was more than 50% and the foregoing amendment was approved by the affirmative vote of 100% of the 5,903 shares of common stock entitled to vote.
