## PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT ("Patent Assignment"), dated as of December 2, 2014, is made by American Locker Group Incorporated ("Assignor"), having an address of 2701 Regent Blvd., Suite 200, DFW Airport, TX 75261, in favor of CKI Locker, LLC ("Buyer"), a Nevada limited liability company, having an address of 4710 Distribution Cir, North Las Vegas, Nevada, 89030, and the purchaser of certain assets of Assignor pursuant to an Asset Purchase Agreement dated as of December 2, 2014 (the "Asset Purchase Agreement") by and between Buyer and Triumph Savings Bank d/b/a Triumph Commercial Finance, as secured party and seller (the "Secured Party").

WHEREAS, under the terms of the Asset Purchase Agreement Secured Party has conveyed, transferred and assigned to Buyer, among other assets, certain intellectual property of Assignor, and Assignor has agreed to execute and deliver this Patent Assignment Agreement for recording with governmental authorities including, but not limited to, the US Patent and Trademark Office;

NOW THEREFORE, Assignor agrees as follows:

For good and valuable consideration, the receipt and sufficiency are hereby acknowledged, Assignor hereby irrevocably conveys, transfers and assigns to Buyer, and Buyer accepts, all of Assignor's right, title and interest in and to the following (the "Assigned Patents"):

(a) any and all inventions, patents and patent applications, including but not limited to the patents and patent applications set forth in Schedule 1 hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals thereof (the "Patents");

(b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing;

(d) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages; and

(e) the right to file any patent applications claiming priority to the Patents and to otherwise seek any patent in any country; file any divisional, continuation, and continuation-in-part applications claiming priority to the Patents where such procedure is proper; and seek reissues or extensions of any Patent.

Assignor authorizes the Commissioner for Patents and any other governmental officials to record and register this Patent Assignment upon request by Buyer. Assignor shall take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, to ensure that the Assigned Patents are properly assigned to Buyer, or any assignee or successor thereto.

This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns. Assignor represents and warrants that Assignor has the full right to convey the entire interest in the Patents.

This Patent Assignment and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Patent Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Nevada, without giving effect to any choice or conflict of law provision or rule (whether of the State of Nevada or any other jurisdiction).
