Confirmatory Patent Assignment Agreement

This Confirmatory Patent Assignment Agreement (the “Confirmatory Assignment”) is effective as of October 15, 2014 (“Effective Date”) by and between A-Tech LLC (“A-Tech” or “Assignor”), a Delaware limited liability company, and Alacritech, Inc. (“Alacritech” or “Assignee”), a California corporation, (each a “Party” and collectively the “Parties”).

WHEREAS, Alacritech previously agreed by a prior Patent Purchase Agreement (“Prior PPA”) and a prior Patent Assignment Agreement (“Prior Assignment”), both of which are by and between Alacritech and A-Tech, the terms from both of which are incorporated herein by reference, that Alacritech sell, assign, transfer and convey to A-Tech and A-Tech accept, all of Alacritech’s rights, title and interest in and to the “Assigned Patent Rights” and “Patents” (as each is defined in the Prior PPA), including but not limited to the United States and foreign patents and patent applications listed on Schedule A (United States Patents and Applications) and Schedule B (Foreign Patents and Patent Applications) hereto, as specified in the Prior PPA and Prior Assignment;

WHEREAS, the Parties previously agreed by a prior Termination Agreement and Assignment (“Termination Agreement and Assignment”), by and between Alacritech and A-Tech, the terms of which are incorporated herein by reference, to terminate the Prior PPA, and as part of the Termination Agreement and Assignment, A-Tech assigned back to Alacritech and Alacritech accepted, the “Assigned Patent Rights” and “Patents” (as each is defined in the Prior PPA) as specified in the Termination Agreement and Assignment;

WHEREAS, A-Tech and Alacritech previously agreed as part of the Termination Agreement and Assignment that A-Tech provide to Alacritech all agreements and any other documentation necessary to affect the assignment in the Termination Agreement and Assignment;

WHEREAS, this Confirmatory Assignment is intended to confirm and affect the prior assignment in the Termination Agreement and Assignment, selling, assigning, transferring and conveying to Alacritech and Alacritech accepting, all of A-Tech’s rights, title and interest in and to the “Assigned Patent Rights” and “Patents” (as each is defined in the Prior PPA), including but not limited to the United States and foreign patents and patent applications listed on Schedule A (United States Patents and Applications) and Schedule B (Foreign Patents and Patent Applications) hereto, as specified in this Confirmatory Assignment;



WHEREAS, as of the execution date of this Confirmatory Assignment, A-Tech is no longer an operating company or in existence;

WHEREAS, A-Tech’s sole member was at all times from inception to dissolution Crown Point Transactions LLC (“Crown Point”);

WHEREAS, Crown Point was and is the only successor-in-interest of A-Tech and has the sole knowledge and authority to dispose of A-Tech’s rights and obligations;

NOW, THEREFORE, in further consideration of the prior mutual agreements and obligations of the Parties and pursuant to the Termination Agreement and Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby confirmed that A-Tech and Alacritech previously agreed and hereby do agree as follows:

1. Assignor hereby sells, transfers, assigns and conveys to Assignee all of its rights, title and interest (for all countries) in and to the Patents, including all reissues, reexaminations, extensions, continuations, continuations in part, continuing prosecution applications, provisionals and divisions of, and all foreign counterparts thereof (including all rights under the patent laws of the United States, any foreign country, or international agreements such as the Industrial Convention for the Protection of Industrial Property), and the following rights of Assignor under the respective Patents: (a) all causes of action (whether currently pending, filed, or otherwise) and other enforcement rights under the Patents including, without limitation, all rights to sue, to countersue and to pursue damages, injunctive relief, and any other remedies of any kind for past, current and future infringement; and (b) all rights to recover and collect settlement arrangements, license payments (including lump sum payments), royalties and other payments due now or hereafter due or payable with respect thereto, under or on account of any of the Patents or any of the foregoing; and (c) any and all privileges, including the benefit of all attorney-client privilege and attorney work product privilege as they relate solely to the Patents.
2. The foregoing sale, transfer, assignment and conveyance of the Patents is subject to all licenses, encumbrances, covenants not to sue, security interests, liens and other restrictions applicable to the Patents as of the Effective Date.
3. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States, whose duty is to issue patents or other evidence or forms of industrial property on applications as aforesaid, to issue the same to Assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.
4. Assignor authorizes and empowers Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable, and to invoke and claim such right of priority without further written or oral authorization from Assignor.
5. Assignor hereby consents that a copy of this Agreement shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document that may be required in any country for any purpose and more particularly in proof of the right of Assignee or nominee to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.
